WHO IS ELIGIBLE?

You are eligible for this insurance if you are a full-time Deputy Sheriffs' Association of San Diego County employee, working at least 30 hours per week, or are an Active Member who is a full-time employee of the San Diego County Sheriffs' Department and are a: Sheriff, Undersheriff, Assistant Sheriff, a regularly employed sworn Peace Officer, sworn Corrections Deputy or Court Service Office employee.

Your spouse and child(ren) are also eligible for coverage. Any child(ren) must be under age 26.

CAN I INSURE MY DOMESTIC OR CIVIL UNION PARTNER?

Yes. Any reference to "spouse" in this document includes your domestic partner, civil union partner or equivalent, as recognized and allowed by applicable law.

AM I GUARANTEED COVERAGE?

This insurance is guaranteed issue coverage – it is available without having to provide information about your or your family's health, if you enroll within 31 days of first being eligible. If you enroll more than 31 days after the date you are first eligible, you will need to complete an Evidence of Insurability Form.

AD&D is available without having to provide information about your health.

HOW DO I PAY FOR THIS INSURANCE?

Premiums will be automatically paid through payroll deduction, as authorized by you during the enrollment process. This ensures you don't have to worry about writing a check or missing a payment.

WHEN CAN I ENROLL?

You may enroll within 31 days of the date you are first eligible to enroll. If you enroll more than 31 days after the date you are first eligible, you will need to complete an Evidence of Insurability Form.

WHEN DOES THIS INSURANCE BEGIN?

Insurance will become effective in accordance with the terms of the certificate (usually the date you become eligible or the date your Evidence of Insurability, if required, is approved).

You must be actively at work with your employer on the day your coverage takes effect. Your spouse and child(ren) must be performing normal activities and not be confined (at home or in a hospital/care facility).

WHEN DOES THIS INSURANCE END?

This insurance will end when you (or your dependent(s)) no longer satisfy the applicable eligibility conditions, premium is unpaid, you are no longer actively working, you leave your employer, or the coverage is no longer offered.

CAN I KEEP THIS INSURANCE IF I LEAVE MY EMPLOYER OR AM NO LONGER A MEMBER OF THIS GROUP?

Yes, you can take this life coverage with you. Coverage may be continued for you and your dependent(s) under an individual conversion life certificate. Your spouse may also continue insurance in certain circumstances. The specific terms and qualifying events for conversion are described in the certificate. Conversion is not available for AD&D coverage.
